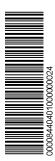

Additional Changes for Chase Checking SM Accounts

We are also changing how you can waive your monthly Service Fee on Chase Checking accounts by establishing a minimum direct deposit amount to waive the monthly Service Fee.

With statement periods beginning February 8, 2011, if you use a direct deposit to waive your monthly Service Fee, you will need to have at least one direct deposit of **\$500 or more** made to your Chase Checking account during your statement period¹. The direct deposit, which must be an ACH credit, may include a payroll, pension or government benefit payment, such as Social Security.

In addition, you can continue to waive your monthly Service Fee on Chase Checking accounts if you have five or more purchases using your Chase Debit Card or Chase ATM Card that post to your account during your statement period. (ATM withdrawals or cash advance transactions do not count.)

Otherwise the monthly Service Fee will apply, which remains at \$6.

¹Two or more direct deposits that add up to \$500 or more, but do not individually equal or exceed \$500, do not qualify.

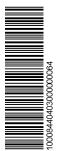

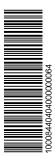
