

We have improved how you can waive the monthly Service Fee with direct deposit on Chase Checking(SM) accounts.

With statement periods beginning on or after August 24, 2011, if you have direct deposits totaling \$500 or more made to this account in a statement period your monthly Service Fee will be waived for that period. (In addition, a single direct deposit of \$500 or more to this account during the statement period will continue to waive the monthly Service Fee for that period). The direct deposits, each of which must be an ACH credit, may

include payroll, pension or government benefit payments, such as Social Security.

In addition, you can continue to have your monthly Service Fee waived on Chase Checking(SM) accounts if you have five or more purchases using your Chase Debit Card or Chase ATM Card that post to your account during your statement period. (ATM withdrawals or cash advance transactions do not count).
